- (F) Quarterly Report of Income and Expenditure of LASC for the Second Quarter of Financial Year 2023-24 Paper No. LASC I/P 26/23
- 8.1 The Chairman said that the quarterly report summarised the income and expenditure of the Council in the second quarter of financial year 2023-24 from 1 July to 30 September 2023. The overall spending position as at the end of September arrived at 46% of the approved budget which was well controlled.
- 8.2 The Chairman mentioned that the expenditure on some items were less than 30%, e.g. the office stationery, the depreciation of fixed assets and transportation fee but these were only minor items. Besides, the annual procurement exercise was usually carried out by the Secretariat in the third quarter of each financial year and relevant expenses would be incurred later this year. For the expenditure on contract staff, the position of contract clerk had been vacant for some time and the Secretariat was trying to recruit a suitable replacement for the position.
